#### **Definitions:**

**Avocats:** *An avocat must be a lawyer or attorney. Avocats may render legal advice on all matters, draft agreements and contracts, handle commercial disputes and collection cases, and plead and defend civil and criminal cases before the French courts to which they are admitted.*

**Notaries:** (*notaires* in France) *In some countries, notaries public, "notaires" or "notars" can perform many of the functions performed by attorneys in the United States. A notary in a civil law country is not comparable to a notary public in the United States. They frequently draft instruments such as wills and transfers of property. In some countries a notary is a public official appointed by the Ministry of Justice, whose functions include not only preparing documents, but the administration and settlement of estates. Such notaries serve as repositories for wills and are empowered to serve legal documents.*
